

# Child Safeguarding Statement

## NAME AND DETAILS OF SERVICE PROVIDER AND NATURE OF SERVICE.

The National Ballet of Ireland (Ballet Ireland) can be defined as stated by Children First Act 2015 as a service which provides educational, research, training, cultural, recreational, leisure, social and physical activities for children.

Ballet Ireland is a registered charity and company limited by guarantee governed by a Board of Directors.

It recognises it holds ultimate responsibility for the wellbeing of participants and staff (including volunteers).

Through its educational programme, Ballet Ireland delivers a range of youth and intergenerational activities involving young people aged 5-18 including: Classes, Workshops, Talks, Performance Projects and Exchange Visits.

## PRINCIPLES TO SAFEGUARD CHILDREN FROM HARM

In line with Children First: National Guidance for the Protection and Welfare of Children (2017) we are committed to safeguarding the children in our care and to child-centred practice in all our work with young people.

We are committed to upholding the rights of every young person who attends our service, including the rights to be kept safe and protected from harm, listened to, and heard.

This statement brings together Ballet Ireland's policies and procedures, which ensures our commitment is enshrined in all aspects of our work with young people.

It is targeted at all adults involved in the work of Ballet Ireland.

Parents and young people will be informed of relevant policies and procedures as they relate to their participation.

## RISK ASSESSMENT


- Procedure for the management of allegations of abuse or misconduct against workers/volunteers of a child availing of our service

- Procedure for the reporting of child protection or welfare concerns to Tusla
- Procedure for provision of and access to child safeguarding training and information, including the identification of the occurrence of harm
- Procedure for maintaining a list of the persons working within Ballet Ireland who are mandated persons
- Procedure for appointing a relevant person
